POLICY FOR PUBLIC PARTICIPATION AT BOARD MEETINGS

In order to manage Board meeting time effectively, **a person wishing to speak is requested to sign in and indicate the topic on which they would like to address the Board.** Up to thirty minutes is allotted for public comments in the opening portion of the meeting . Therefore, a person’s remarks may be limited depending on how many request to speak. A person may not be recognized to speak again until all others seeking the floor have had a turn.
